Dear Davidson Fellows Applicant,

Thank you for your interest in applying for the Davidson Fellows Scholarship.

Our purpose in offering the Davidson Fellows Scholarship is to recognize outstanding achievements of young people who can demonstrate the development of their talents with a significant piece of work. We seek to recognize and award the truly *extraordinary* in Science, Technology, Mathematics, Music, Literature, Philosophy or Outside the Box. Each submission must be a piece of original work recognized by experts in the field as significant and it must have the potential to make a positive contribution to society. The Davidson Institute is looking for students whose projects are at or close to the college graduate level with a depth of knowledge in their particular area of study. This scholarship is not geared toward students at the novice level.

The Davidson Fellows Scholarship is designed to recognize prodigious achievement and is not a competition. Each submission is evaluated on its scope and quality, level of significance, the applicant's depth of knowledge and understanding of the work in the related domain area. Young people selected as Davidson Fellows receive a \$10,000, \$25,000 or \$50,000 scholarship to further the development of their talent through attendance at an accredited academic institution. There is also a media component to being named a Davidson Fellow which helps us highlight the Fellows' extraordinary work as well as the broader mission of the Davidson Institute.

In addition, Davidson Fellows are encouraged to make a moral commitment to support others and develop their talents. Davidson Fellows will have an opportunity to serve as role models and mentors to other profoundly intelligent young people.

The Davidson Institute for Talent Development is a nonprofit organization whose mission is to recognize, nurture, and support profoundly intelligent young people and to provide opportunities for them to develop their talents to make a positive difference.

Eligibility and Deadlines

To be eligible for the Davidson Fellows Scholarship, each applicant must:

- Be a U.S. citizen residing in the United States, or a Permanent Resident of the United States residing in the United States or be stationed overseas due to active U. S. military duty.
 - Be 18 or younger on October 4, 2012. There is no minimum age for eligibility.
 - Have completed high level work in one of the following categories:
 - Literature
 - Mathematics
 - Music - Composer, Classical Instrumentalist or Other Instrumentalist
 - Outside the Box
 - Philosophy
 - Science
 - Technology
 - Be able to demonstrate that the work is the applicant's own creation. Guidance from teachers and mentors is acceptable, as long as the work is the applicant's.
 - Be available to attend, with a parent/guardian, the awards reception and other recognition events to be held in Washington, D.C. October 2, 3 and 4, 2012.

There are **two** deadlines in the 2012 Davidson Fellows application process.

Monday, January 16, 2012: Preliminary Submission Overview Form

- Each applicant must complete a Preliminary Submission Overview Form and return it, via the "Submit" button in the upper right corner of the form, to the Davidson Institute.

Wednesday, February 1, 2012, 5 p.m. Pacific Standard Time (PST): Davidson Fellows Application; individual category requirements; three Nominator Forms

- **Davidson Fellows Application Materials:** Application, individual category required elements, Attachments 1 through 3.
- **Nominating Forms:** Three Nominating Forms are required; all nominators must be familiar with the work being submitted. Family members may not serve as nominators. All Nominating Forms must be submitted directly to the Davidson Institute by the nominator. It is the applicant's responsibility to make sure the Nominating Forms arrive on or before the deadline of February 1, 2012, 5 p.m. PST.

The Institute will not be able to immediately confirm receipt of application materials or nominating forms due to volume. All confirmations will be sent via email within two to three business days.

There will be no deadline extensions.

How to Apply

Step One:

Carefully review the Davidson Fellows website, www.DavidsonGifted.org/Fellows, including the **Frequently Asked Questions (FAQ) and Project Criteria sections.**

Step Two:

Download the following application components from the "[How To Apply](#)" page of the Davidson Fellows website:

- Davidson Fellows Preliminary Submission Overview Form
- Davidson Fellows Application
- Your individual category requirements
- Davidson Fellows Nominating Form

Step Three:

Complete and submit the Davidson Fellows Preliminary Submission Overview Form by **January 16, 2012**. Confirmation of receipt notices will be sent via email to the address provided on this form.

Step Four:

Three individuals who are familiar with your work must each submit a Nominating Form, family members may not serve as nominators. Email the Davidson Fellows Nominating Form link, from the "[Download Application](#)" page, to your three nominators (three nominators are required). Follow-up with your nominators to make sure they have submitted their form to the Institute. ***Applications with missing Nominating Forms will be disqualified.***

Step Five:

Email all application components to DavidsonFellowsApplications@DavidsonGifted.org no later than 5 p.m. PST on February 1, 2012.

The completed application includes the following elements: a Davidson Fellows Application, all required elements of your specific category, Attachments 1 through 3.

The Davidson Institute strongly recommends that you keep a copy of your application, the attachments and the required elements for your category. Any intellectual property contained in the application materials will remain the property of the applicant.

The Davidson Institute will not be able to immediately confirm receipt of applications due to volume. All confirmations will be sent via email within two to three business days.

All applicants will be notified by mail of their application status on or before July 14, 2012.

Rules and Regulations

- Each applicant may submit only one application.
- Group or team projects are not eligible. The work must be that of a single individual.
- Each submission must include the official Davidson Fellows application plus all of its attachments and required elements as specified by category, as well as three nominating forms. Incomplete applications will be disqualified.
- Applications involving human subjects, live vertebrates or live invertebrates are not eligible. However, the Davidson Fellows Program will consider certain tissue related projects, if and only if the applicant can demonstrate:
 1. the materials were collected for other purposes; AND
 2. the student is collaborating with a qualified lead scientist; AND
 3. the lead scientist provides to the Institute documented approval from a recognized Institutional Review Board (IRB) or Scientific Review Committee (SRC).

Documentation must be emailed to DavidsonFellows@DavidsonGifted.org and will be reviewed by the Davidson Institute for Talent Development, who, at its sole discretion, will determine eligibility. The Davidson Institute of Talent Development may, in its sole discretion, also require that other conditions be met before tissue related projects will be further considered.

Conditions of Scholarship

Each scholarship may be used only for qualified tuition and related expenses, as defined in the Internal Revenue Code §117(b) and related regulations.

The Institute shall determine the time and conditions of payment of scholarships at its sole discretion. The Davidson Institute may specify the documentation required to assure that the recipient is following an appropriate course of study.

If the Davidson Fellow withdraws from school, or his or her progress is unsatisfactory and the Fellow makes no alternate arrangements to pursue courses at the same or another educational institution, then, at its sole discretion, the Davidson Institute may terminate the scholarship.

Disqualifications

The Davidson Institute and/or the Judges may decide to disqualify an application if it or they are of the opinion that there has been no timely and proper submission of the application, there is a lack of sufficient merit, and/or if there is a violation of any portion of the rules or regulations.

Fraud and misconduct are not condoned at any level of research or project development. Plagiarism, use or presentation of another person's work as one's own, forgery of signatures and fabrication or falsification of data or portfolio materials will not be tolerated. Fraudulent projects will be disqualified.

If an application contains materials that appear to violate any of the rules and regulations, the Davidson Institute and/or the Judges may, at its or their discretion, disqualify the application in its entirety and/or withdraw an award that has not been previously paid out to the applicant.

Disqualification may also occur if an application that is submitted on time contains any omissions or errors. However, the Davidson Institute and/or the Judges may, at its or their sole discretion, contact the applicant pointing out the violation and giving the submitting applicant a designated period of time to complete or correct such application.

Employees, trustees (and their immediate family members) of the Davidson Institute and the Judges (and their immediate family members) are not eligible to apply for or receive a Davidson Fellows Scholarship.

Judging Criteria

The following criteria, weighted as indicated below, will be used for the selection of Davidson Fellows:

50 Points	30 Points	20 Points
<i>The quality and scope of the entry</i>	<i>The level of significance of the work</i>	<i>The applicant's depth of knowledge and understanding of the work and the related domain area.</i>

The selection of Davidson Fellows is strictly based upon the above criteria.

The Davidson Institute does not discriminate based on race, gender, religion, ethnicity or physical disability. All selection decisions are final.

Selection

Each submission is examined for completeness and accuracy. Qualified entries are then sorted by category and evaluated by an independent team of judges comprised of professionals with expertise in related domain areas. The team of judges may, at their sole discretion, consult with additional experts to assist in evaluating the merits of each submission.

The Davidson Fellows Scholarship is not a competition; we seek to recognize and award the **extraordinary**. Judges will thoroughly evaluate each application, considering its scope and quality, level of significance and the applicant's depth of knowledge and understanding of the work and the related domain area.

The independent team of judges will identify which applicants will be named Davidson Fellows and decide whether they will receive a \$10,000, \$25,000 or \$50,000 scholarship. All applicants will be notified of the judges' decisions on or before July 15, 2012.

Individuals named as Davidson Fellows will be honored at an awards reception to be held in Washington, D.C. October 2, 3 and 4, 2012.
